GSG Impact

GSG Impact is a global not-for-profit organisation, established under the 2013 UK G8 presidency, with the goal to create the infrastructure and incentives for capital to flow for measurable, positive social and environmental impact. We do this by creating, accrediting, and supporting national impact institutions - GSG National Partners. Today we are responsible for over 40 National Partners covering 2/3 of the global population. Over 1/2 of our National Partners are in emerging markets, with many more in development. Collectively GSG Impact and our National Partners work together as the GSG Impact Partnership.

We are a powerful global movement, developing innovative impact investment solutions and driving national and international policy and regulatory change to enable these solutions to be adopted at scale. Our mission is to build impact economies across the globe, creating the infrastructure and incentives for capital to flow for the SDGs & climate goals. We are very focused on mobilising capital for impact in emerging markets. Our collective efforts have influenced over \$3 billion in catalytic capital and helped launch more than 15 impact investment vehicles.

With staff in various global locations, including London, Paris, Rome, Buenos Aires, Nairobi, and Bangkok, GSG Impact leverages its global presence to drive systemic change and expand its impact.

Role Overview

- As Senior Manager Investible Vehicles, you will play a pivotal role in supporting GSG Impact's
 efforts to expand and strengthen our National Partners' capacity to mobilise capital and launch
 investible vehicles for impactful investments.
- This position will focus primarily on working across the GSG Impact Partnership in supporting the creation and scaling of large-scale impact investment vehicles, including funds of funds and impact wholesalers (c 75% of time), and on advancing knowledge products and advocacy (c 15% of time).

Key Responsibilities

Technical assistance, strategic advisory, and project management support for National Partners (~75%)

- Provide technical assistance and strategic advisory to National Partners, guiding them through the process of setting up and scaling impact investment structures.
- Provide support to National Partners in the design, implementation, and scaling of large-scale impact investment vehicles (e.g. funds of funds like Ci-Gaba in Ghana, Nigeria Impact Wholesaler, Zambia Small and Growing Business Initiative) to unlock capital for SDG-aligned investments.
- Build and manage relationships with key stakeholders, including development finance institutions (DFIs), asset managers, and government agencies, to catalyse capital for high-impact solutions.
- Coordinate cross-functional teams within GSG Impact to ensure the successful delivery of complex initiatives in emerging markets across Africa, Asia, and Latin America.
- Monitor and evaluate the progress of projects, ensuring that lessons learned are captured and disseminated for future scaling.

Knowledge Products and Advocacy (~15%)

- Engage with working groups, roundtables, and other forums to contribute to the development of innovative tools, frameworks, and best practices that advance the impact investment sector.
- Contribute to advocacy efforts related to SME finance and other key topics, leveraging GSG's network to influence policies and practices that support sustainable investments.
- Coordinate with internal and external teams to align knowledge products with the broader GSG Impact strategy and ensure their relevance to global policy agendas.

General Responsibilities (~10%)

- Collaborate with internal teams globally, including Fundraising and Communications, to ensure the alignment of initiatives and maximise the impact of GSG Impact's work.
- Represent GSG Impact at global conferences, forums, and meetings to raise the profile of our work and advocate for systemic change in the financial sector.
- Contribute to monitoring, evaluation, and reporting activities to ensure the impact of GSG Impact's initiatives is tracked and communicated effectively.

- Experience in capital mobilisation structuring: proven track record in designing, structuring, implementing, and scaling large and small impact investment vehicles such as funds of funds, wholesalers, or other catalytic finance structures.
